



INVITATION TO QUOTE

SNOW REMOVAL

LAKEVILLE FIRE HALL & DRY HYDRANT

The District of Carleton North hereby invites quotes for the following items of work. All items of work refer to the period November 1, 2024 – April 30th, 2025.

1. The removal of snow from the area indicated below around the fire hall, and dry hydrant at By The Lake Community Center as defined Lakeville Fire Hall
 - All remaining snow in front of overhead vehicle doors and other remaining entryways and exits must be cleared immediately after each plowing at The Fire Hall.
 - Sanding or salting of all area **as requested**
 - **The Hydrant at By The Lake Community Center and the cement slab by the bridge**
2. Snow removal will be required after any snowfall with an accumulation of three inches (3”) more or less or when an accumulation of three inches (3”) more or less has resulted from multiple minor snow falls. Due to the emergency nature of the Fire Department’s operation, the contractor should never hesitate to plow if snow accumulation may pose a hindrance to the fire vehicles.
3. Acceptance of the snow removal contract includes responsibility for all proper licenses, permits, insurances and liability (two million dollars per occurrence) related to the work. **The Contractor agrees that he shall provide and maintain, at all times during the term of this contract motor vehicle public liability insurance and comprehensive general liability insurance, for no less than Two Million Dollars (\$2,000,000.00) respectively per occurrence. Proof of insurance must be provided to the District of Carleton North upon request, prior to award.**
4. The Contractor, when submitting a bid for this tender, must include either
 - i) proof of Worksafe NB coverage for all employees, or
 - ii) the signed Waiver Form (attached herewith as Appendix A 1 when the bid is submitted).

Failure to provide the information in either 1(i) or 1(ii) above at the time of bid submission will be grounds for non-acceptance of the Quote.

If the Contractor provides proof of Worksafe NB coverage, and is awarded the tender, the Local Services Manager may request current documentation from the Contractor from time to time, which will show coverage. Failure to provide the appropriate documentation within the timeframe agreed to between the Local Services Manager and the Contractor, shall be grounds for the termination of the contract.

- The person(s) who will be doing the work
 - The amount to be charged for each plowing and sanding/salting occurrence
 - A copy of this quote
