Schedule "A" DISTRICT OF CARLETON NORTH BY-LAW NO. A-6 A By-law Respecting Peddlers

Section 3.1 of By-law No. 11 states: *No person shall, on Town property, peddle or hawk, or carry from place to place for peddling or hawking, any goods or merchandise unless that person has been issued a peddler's license therefore by the Municipal Representative.*

Section 3.5 of By-law No. 11 states: An application for a peddler's license must include written consent from the owner or duly authorized occupier of the land where the peddler proposes to carry on business stating that the peddler has permission to use the land.

Section 3.7 of By-law No. 11 states: *Upon acceptance of the peddler's application, a license will be issued to that peddler after payment by the peddler of a fee as follows:*

\$50.00 per day HST Exempt \$100.00 per week HST Exempt \$250.00 per month HST Exempt \$1250.00 per year HST Exempt
