- 4.5 Bids in which the amount is less than the amount specified in the listed item above will be rejected.
- 4.6 In the event there is the same price by two or more bidders, those bidders will be given an opportunity to submit a revised bid. If a tie occurs again, the Public Safety Manager/Treasurer will draw a name to determine the successful bidder.
