## 5. **BUSINESS ARISING FROM THE MINUTES:**

1. **Juniper Organics** – at our last Council Meeting, a complaint from a resident was raised regarding Juniper Organics and the peat moss particles entering homes and impacting swimming pools and mini-split heat pumps and breathing concerns. The District of Carleton North sent a letter to J.D. Irving and received the below response.

*Dear Mr. Harvey:*

*Thank you for sharing the concerns raised regarding peat moss dust impacting our neighbours in the community of Juniper. As a result of your notice, and another recent concern raised by a neighbour, we initiated an investigation into what may have caused an increase in dust leaving the site.*

*An inspection of our dust collection system identified the possibility of a defective filter bag, which could cause dust to bypass the collection system and become airborne. We will be replacing all filter bags in the dust collection system. This work is currently scheduled for August 8th.*

*We will continue to monitor the presence of dust following this scheduled maintenance.*

*Thank you again for sharing this concern with us and we appreciate the opportunity to respond to this matter.*

**6. PRESENTATIONS:****1. Natalie Stacey – Western Valley Female Hockey Association**

Natalie Stacey, Treasurer for the Western Valley Female Hockey Association along with the President, Becky York came to Council to discuss ice rates and ice times for the association. Currently, they are paying the same Youth Hockey rate and have requested that they pay the Minor Hockey rate. Ms. Stacey noted Western Valley Female Hockey Association has been in place for some time, but due to numbers they have not been able to have a team for 3-4 years. Amazingly, female hockey has began to gain a lot of momentum and is growing fast. The Association is a non-profit organization with all female recreational and competitive players from the Tobique First Nation, Perth Andover, Plaster Rock, District of Carleton North, Woodstock, Woodstock First Nation and Nackawic areas. Our mission is to offer female hockey players the ability to grow and develop at competitive and elite levels. The Association has proven to gain confidence and building long lasting friendships between these “Mighty Chicks”. They promote healthy and active lifestyles for young females. The goal of the association is to develop character and discipline, as well as raising their awareness on the importance of academic success, preparing the young female players for a productive life with the possibility of earning a hockey scholarship. This year, they were able to host provincials and came in 3<sup>rd</sup> out of 14 teams. This coming season they will have a U13 team and will belong to a league. They will be potentially using 144 hours of ice team this season. Their three asks were to be charged the same rate as CMHA, to work with the staff for booking the ice teams and to give the team an equal opportunity to play hockey with their peers. Mayor and Council advised that they would discuss and advise.
